WATER SUPPLY:-

The colonizer has completed the Water Supply distribution Network in the above said area and RCC underground tank (UGT) with a capacity of 225 KLD, Pump chamber with pumping machinery etc. has been installed by the colonizer Colonizer has also installed 2 No(s) tube well(s) to meet out the daily water requirement of the above said area. The colonizer has given the undertaking/ affidavit that colonizer will make his own arrangement for water requirement of the colony till the external water supply system is laid by HSVP/ Govt. and colonizer will also responsible for integrating internal water supply system with the external Water supply system to be laid by HSVP/ Government. The colonizer bear 100% responsibility for the quality/specification of the work/material utilized in the work and shall have to replace/repair any work/item, if required, at any stage. He will also construct additional structures if required as decided by HSVP at later stage.

> SEWERAGE:-

The colonizer has completed the internal Sewerage system for the above said area including laying of SW pipe line network of 200mm internal diameter, construction of main holes and STP of 280 KLD capacity for initial treatment of sewage effluent in the premises of the colonizer and treated water is being used in toilets by dwell plumbing system. The service plan indicating the development works completed by the developers for Affordable Residential Plotted Colony under DDJAY developed by Shiv Yash Infratower LLP in Sector-36, Bahadurgarh, District-Jhajjar measuring 6.3875 acres (License No. 59 of 2019) have been got verified and are returned herewith, with the following remarks/ comments:-

- 1 The external services with respect to affordable residential plotted colony under DDJAY developed by Shiv Yash Infratower LLP over an area measuring 6.387 5 acres (Licence No.59 of 2019) in Sector 4A, Bahadurgarh have been got chec ked and reportedly laid at site and are operational/functional. The services include W ater Supply, Sewerage, SWD, Roads, Street Lighting and Hort.
- 2 The plans enclosed bearing drawing no. nil (04 Nos.) dated Nil and as supplied vide DTCP office memo no. LC-320-JE(MK)/2020/22402 dated 21.12.2020, showing the proposal and services therein have been considered to be correct for the purpose of services only.
- 3 The title and the name of the Licence, area under Licence and various pockets shown on the plans issued to Shiv Yash Infratower LLP may be examined by DTCP Office.
- 4. The services will be laid by the colonizer up to alignment of proposed external services. All the link connection with the HSVP system will be done by the colonizer at his own cost with the prior approval of the competent authority.
