v. The real estate agent shall provide assistance to enable the allottees and promoter to exercise their respective rights and fulfill their respective obligations at the time of

booking and sale of any plot, apartment or building, as the

vi. The real estate agent shall comply with the provisions of the Act and the rules and regulations made there under;

vii. The real estate agent shall not contravene the provisions of any other law for the time being in force as applicable to him;viii. The real estate agent shall discharge such other functions
