This registration bearing No. HRERA-PKL-REA-2141-2023 Dated 17.10.2023 is granted under section 9 (3) (a) of the Real Estate (Regulation and Development) Act, 2016 and Rule 10(2) of the Rules 2017 to Ms. Ritu Jain D/o Sh. Ashok Jain, F3, First Floor, Plot No-7, Vardhaman Shopping Corner, DP Block Mkt, Pitampura, Delhi, 110034, to act as a real estate agent to facilitate the sale or purchase of any plot, apartment or building, as the case may be, in real estate projects registered in the State in terms of the Act and the rules and regulations made thereunder,

This registration is granted subject to the following conditions, namely:

- (i) She shall comply with the provisions of the Act and the rules and regulations made thereunder;
- (ii) She shall not facilitate the sale or purchase of any plot, apartment or building, as the case may be, in a real estate project or part of it, being sold by the promoter which is required but not registered with the Authority;
- (iii) She shall maintain and preserve such books of account, records and documents as provided under Rule 13;
- (iv) She shall not involve herself in any unfair trade practices as specified under Section 10 (c) of the Act;

- She shall facilitate the possession of all information and documents, as the (v)allottee is entitled to, at the time of booking of any plot, apartment or building, as the case may be;
- She shall provide assistance to enable the allottees and promoters to (vi) exercise their respective rights and fulfill their respective obligations at the time of booking and sale of any plot, apartment or building, as the case may be.
- She shall not contravene the provisions of any other law for the time (vii) being in force as applicable to her;
- She shall discharge such other functions as may be specified by the (viii) Authority by regulations;
- (ix)She shall follow guidelines issued by Government of India on Anti-Money Laundering (AML) Standards and Combating the Financing of Terrorism (CFT) -Obligations for Real Estate Agents under the Prevention of Money Laundering Act, 2002 and the Prevention of Money Laundering (Maintenance of Records) Rules 2005.
- She shall have to adhere to client account opening Procedures and maintain records of such transactions as prescribed by the PMLA and rules notified there under.
- The Real Estate Agents shall also be required to report the specified transactions, including the suspicious transactions with a view to provide deterrence to the money Laundering and Financing of Terrorism at the following address: -
