- (iii) She shall maintain and preserve such books of account, records and documents as provided under Rule 13;
- (iv) She shall not involve herself in any unfair trade practices as specified under Section 10 (c) of the Act;

- She shall facilitate the possession of all information and documents, as the allottee is entitled to, at the time of booking of any plot, apartment or building, as
- She shall provide assistance to enable the allottees and promoters to (vi) exercise their respective rights and fulfill their respective obligations at the time of booking and sale of any plot, apartment or building, as the case may be.
- (vii) She shall not contravene the provisions of any other law for the time being in force as applicable to her;
- (viii) She shall discharge such other functions as may be specified by the
- She shall follow guidelines issued by Government of India on Anti-Money (ix)Laundering (AML) Standards and Combating the Financing of Terrorism (CFT) – Obligations for Real Estate Agents under the Prevention of Money Laundering Act, 2002 and the Prevention of Money Laundering (Maintenance of Records) Rules
- She shall have to adhere to client account opening Procedures and maintain records of such transactions as prescribed by the PMLA and rules notified there
