The promoter i.e. M/s Goel and Sons Developers Pvt. Ltd. has applied on dated 04.08.2022 for registration of their affordable plotted colony under DDJAY namely "Golden Park" located at revenue estates of village Khailka, Sector-04, Sohna, Gurugram under section 4 of Real Estate (Regulation and Development), Act 2016.

This application is for project land admeasuring an area of 18.025 acres for which the license vide no. 76 of 2022 dated 24.06.2022 valid upto 23.06.2027 has been issued by DTCP in favour of M/s Goel and Sons Developers Pvt. Ltd.

The current application pertains to 324 residential plots and 1 commercial block out of which 164 are frozen and 45 plots are mortgaged. On scrutiny of the application, it was found that there were deficiencies in the application which were conveyed to the promoter through first deficiency notice vide no. HARERA/GGM/RPIN/487 dated 18.08.2022 with an opportunity of hearing on 22.08.2022.
