- a) The registration fee is deficit by Rs. 68,233/-.
- b) Address of person operating the RERA account has not been mentioned in online application REP-I(Part-D).
- c) As per LLP Agreement submitted by the applicant/promoter Sh. Prahlad Gautam is not a partner in the firm, whereas, in online application he has been mentioned as a partner. However, Sh. Prahlad Gautam appearing on behalf of applicant/promoter stated that since, it's a clerical mistake, therefore, same may be corrected.
- d) The license has been granted in favour of Amolik Buildcon LLP(landowner) alongwith seven other individual land owners in collaboration with Amolik Buildcon LLP. The developer-



promoter has submitted 3 Collaboration Agreements (CA) and 3 General Power of Attorney (GPA) executed between the licencees and the applicant promoter.
