Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 17.12.2018.

Dream Build Creations Company. – Project "Model Town" situated in Village - Harchandpur, Sec-77, MBIR (Old Sector-10A) Tehsil- Bawal, Distt.-Rewari

The application for registration of a residential group housing colony on land measuring 10.50 Acres namely "Model Town" situated in Sector-77, Village Harchandpur, Rewari came up for consideration of the Authority today. The Authority after consideration of the application observed as under:

- Project land area measuring 10.50 Acres is owned by three collaborators; area measuring 5.54 Acres is owned by M/s Dream Build Creations Company and remaining 4.96 Acres by other two collaborators, namely, M/s Maskot Infrabuild Pvt. Ltd. and M/s Shack Infrastructure Pvt. Ltd.;
- ii. In the registered collaboration agreement dated 15.07.2016, it has been mentioned that the entire development will be done by M/s Dream Build Creations Company at its own cost and 50% of the developed area of 4.96 Acres owned by the remaining two collaborators will be marketed by M/s Dream Build Creations Company and the remaining 50% area will be marketed by M/s Maskot Infrabuild Pvt. Ltd. and M/s Shack Infrastructure Pvt. Ltd.,
- iii. Accordingly, in the layout plan, the plots/ area to be allocated to the other two collaborators, namely, M/s Maskot Infrabuild Pvt. Ltd. and M/s Shack Infrastructure Pvt. Ltd. should be earmarked specifically;
- iv. Deficit fee of Rs.51,930/- should be deposited with the Authority;
- v. Figures of the amount mentioned in Part-C of the proforma have been shown incorrectly, it should be corrected.
