20. Case History:

The Promoter M/s Adani M2K Projects LLP who is a collaborator applied for the registration of real estate commercial plotted colony (Distinct Commercial Component of DDJAY Plotted Colony) namely "Oyster Greens" located at Sector-102 &102A, Gurugram under section 4 of the Real Estate (Regulations and Development) Act, 2016 vide central receipt no. 48125 dated 24.01.2023 and RPIN-576. The Temp I.D. of REP – I (Part A-H) is RERA -GRG-PROJ-1264-2023. The project area for registration is 0.5996 acres commercial part of the licensed area i.e., 14.99375 acres vide License no –44 of 2021 dated 10.08.2021.
