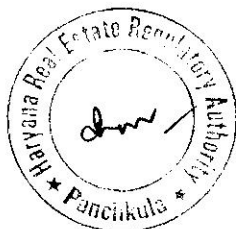
**Consideration of the applications received by the Authority for Registration of New Projects.**
