1. The matter pertaining to registration of this project came up for consideration of the Authority today. License no. 70 of 2009 dated 24.11.2009 was granted for an area measuring 99.309 acres was granted for development of a residential plotted colony in Sector 26, 26A, 33 & 34, Sonipat. Subsequently, License No. 99 of 2021 dated 18.11.2021 for an additional land measuring 3.725 acres was granted in favour of Nilgiri Land Holdings Ltd., Indiabulls Commercial State Ltd., Indiabulls commercial Property ltd., Smt Krishna Gahlawat, Indiabulls Infrastructure Project Ltd. in collaboration with India Bulls Estate Ltd. for development of a residential plotted colony. Subsequently, through conveyance deed dated 02.05.2022, between the licencee companies and Kristina Infrastructure Pvt. Ltd., the commercial component measuring 2.0834 Acres has been transferred in the name of Kristina Infrastructure Pvt. Ltd.

- 2. The application submitted by the promoter has been examined and following deficiencies are observed:
 - i. Balance sheet for the year 2021-22 is not submitted.



- ii. CA certificate is not in order.
- iii. Date of approval of layout plan and building plans has not been mentioned in Form REP-1 Part C.
- 3. Applicant/promoter should comply with the observations before the next date of hearing. Adjourned to <u>08.05.2023</u>.
- 4. In case promoter/applicant furnishes the aforesaid information before the next date of hearing, their application will be considered by the Authority in its meeting on Monday following the date of such submission.
