## 17. | Case History:-

The promoter M/s Microtek Urbandevelopers Pvt. Ltd. who is a license holder had applied for the registration of real estate project namely "Microtek Success Hub" located at Sector-95A, Gurugram under section 4 of the Real Estate (Regulations and Development) Act, 2016 vide central receipt no. 48379 dated 30.01.2023 and RPIN-581. The Temp I.D. of REP – I (Part A-H) is RERA -GRG-PROJ-1295-2023. The project area for registration is same as that of the licensed area i.e., 4 acres. License no – 201 of 2022 dated 01.12.2022 valid up to 30.11.2027.
