<p>The promoter M/s Microtek Urbandevelopers Pvt. Ltd. who is a license holder had applied for the registration of real estate project namely "Microtek Success Hub" located at Sector-95A, Gurugram under section 4 of the Real Estate (Regulations and Development) Act, 2016 vide central receipt no. 48379 dated 30.01.2023 and RPIN-581. The Temp I.D. of REP – I (Part A-H) is RERA -GRG-PROJ-1295-2023. The project area for registration is same as that of the licensed area i.e., 4 acres. License no – 201 of 2022 dated 01.12.2022 valid up to 30.11.2027.</p> <p>The application for registration was scrutinized and 1<sup>st</sup> deficiency notice vide notice no. HARERA/GGM/RPIN/581 dated 07.02.2023 was issued to the promoter with an opportunity of being heard on 13.02.2023.</p> <p><b>On 13.02.2023</b>, Ms. Asha, Chartered Accountant briefed about the facts of the project. None is present on behalf of the promoter. The promoter is directed to rectify the deficiencies before the next date of hearing. The matter to come up on 27.02.2023.</p> <p><b>On 27.02.2023</b>, Sh. Sumeet, Engineer Executive and Ms. Asha, Chartered Accountant briefed about the facts of the project. Sh. Naveen Singla (CA) is present on behalf of the promoter. The AR of the promoter seeks one month time to comply with the deficiencies pointed out. The matter to come up on 27.03.2023.</p> <p><b>On 27.03.2023</b>, the matter was adjourned to 29.03.2023.</p> <p><b>On 29.03.2023</b>, Sh. 


