Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 09.10.2023.

## Item No. 229.38

(iii) Promoter: Jatin Dhawan/ Om Developers.

Project: "Green Residency" a Residential Plotted Colony on land measuring

4.843 acres situated in Sector 36 A, Rohtak.

Temp ID: RERA-PKL-1327-2023

Present: Adv. Madhur Panwar on behalf of promoters.

- When this matter was last heard on 21.08.2023, following deficiencies were 1. conveyed:-:-
  - Final approval granted by Directorate of Urban Local Bodies, Haryana has "į not been enclosed with the application.
  - Collaboration agreement and GPA could only be examined after schedule of land/ownership papers are enclosed alongwith final permission.
  - Total area of the scheme is 4.843 acres, however land utilization table shows total area of 4.98 acres. This needs to be reconciled. iv.
  - Estimated cost of internal services (under REP-I Part C) have not been submitted.
  - Expenditure to be incurred in each quarter has not been submitted in REP I Part C. vi.
  - GST certificate of Om Developers has not been submitted. vii.
  - Date of completion of project in REP-I is August, 2025 however in REP-II, the same is mentioned as June, 2025. The same needs to be reconciled.
  - Copies of allotment letter and agreement to sell have not been attached with the application.
  - Approved layout Plan of the colony has not been attached. Deficit fee, if any could be computed only after approved layout plan is enclosed.
  - Balance Sheet for the year last 3 years have not been submitted.



- xi. CA certificate as per format approved by the Authority has not been attached. Copy of approved format is enclosed herewith.
- xii. Address of persons operating escrow account under REP I Part B is not submitted."
- 2. In view of the aforesaid observations, Applicant/Promoter has submitted reply dated 29.09.2023 which has been examined by the Authortiy and it further observes that:
  - a. Registration fee is deficit by Rs. 10,130/-
  - b. The promoter should also submit a list of members approved by the Registrar of Cooperative societies showing that 8 plots will be allotted to the developer.
  - c. The promoter should clarify as to how will 70% amount go into the rera account and how will the internal development works be executed.
  - d. The Promoter should also clarify as to who will maintain the colony for a period of five years after the grant of completion certificate
- 3. Adjourned to 11.12.2023. In case promoter/applicant furnishes the aforesaid information before the next date of hearing, their application may be considered by the Authority in its meeting on Monday following the date of such submission.
