23. Case History:

The Promoter M/s Ganga Global Homes Pvt. Ltd. who is a license holder applied for the registration of real estate group housing colony namely "Nandaka" located at Sector-84, Gurugram under section 4 of the Real Estate (Regulations and Development) Act, 2016 vide central receipt no. 60002 dated 11.10.2023 and RPIN-657. The Temp I.D. of REP – I (Part A-H) is RERA -GRG-PROJ-1452-2023. The project area for registration is 5.8406 acres but the licensed area i.e., 8.34375 acres granted under License no – 127 of 2023 dated 16.06.2023 which is valid upto 15.06.2028.

The DTCP has granted license no. 127 of 2023 for the development of mix land use colony having total area 8.3438 acres. However, the promoter has applied for the registration of 5.8406 acres as Phase 1 and the building plans if approved, by the DTCP, Haryana are not submitted by the promoter with the application for registration of the project to ascertain as to whether the phasing has been approved by the competent Authority or not.

The application for registration of group housing colony was scrutinized and 1^{st} deficiency notice vide notice no. HARERA/GGM/RPIN/657 dated 13.10.2023 was issued to the promoter with an opportunity of being heard on 16.10.2023.

On 16.10.2023, Sh. Ashish Kush, Planning Executive and Ms. Asha, Chartered Accountant briefed about the facts of the case. Sh. Neeraj Mishra, Executive Director of the company and Sh. Ashwani Kumar are present on behalf of the promoter. The AR of the promoter states that building plans have been approved by DTCP and approval letter remain to be signed/issued which shall be submitted within a week. Further, the AR seeks one week time to submit deficit documents. The matter to come up on 23.10.2023.

The promoter has submitted the reply on 12.10.2023, 13.10.2023, 16.10.2023 and 23.10.2023 which were scrutinized and the status of the documents is mentioned below:
