When this matter was last heard on 24.01.2024, following deficiencies were 1. observed:-

Demarcation and Zoning plan duly approved by DG, TCP has not been submitted. ii.

CA certificate is not as per format prescribed by the Authority.

Applicant/Promoter vide reply dated 23.02.2024 has complied with the aforesaid 2. deficiencies.

In view of the above, Authority decides to register the project with the following special conditions:

Promoter shall submit a copy of service plans/estimates to the Authority immediately after their approval by Town & Country Planning Department.

ii. Promoter shall submit duly approved building plans in respect of commercial pocket measuring 0.480 acres to the Authority along with deficit fee, if any. Till then, the promoter shall not sell/dispose of any part/unit of the commercial pocket. Estate Regu



- iii. Promoter shall also submit a copy of NOC/Clearance as per provisions of notification dated 14.09.2006 issued by MOEF, Govt. of India (if applicable) before execution of development works at site.
- iv. The promoter shall submit the details of the RERA bank account (where 70% of the amount received from the allottees shall be deposited) within a period of 15 days from the issuance of this registration certificate, till which time no plots shall be sold. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority.
- That following plots mortgaged with DTCP, Haryana in lieu of Bank Guarantee of EDC and IDW shall only be sold after release of mortgage:-
