### (E) VALIDITY OF REGISTRATION

The registration of this project shall be valid for the period commencing from 06th June 2022 and ending with 30th June, 2023 (completion date as declared by the promoter in REP-II) unless extended by the Authority in accordance with the Act and rules made thereunder subject to compliance of provisions of rule 5(1) of the Haryana Real Estate (Regulation and Development) Rules, 2017.

This registration certificate is based on the information supplied by the promoter and an authenticated detailed project information (DPI) and declaration by the promoter is annexed herewith, which shall be read as part of this registration certificate.

This registration certificate is granted in pursuance to the agenda approved by the authority and detailed order dated 06.06.2022 passed in this regard.

#### (F) CONDITIONS OF REGISTRATION

- This registration is granted subject to the following conditions, namely: 2.
- The promoter shall enter into an agreement for sale with the allottees as (i) prescribed in the Haryana Real Estate (Regulation and Development) Rules, 2017 and amended as per requirements and approved by the authority.

(ii)	The promoter shall submit the road access permission within 2 months from the issuance of the registration certificate;				
(iii)	The promoter shall submit the Bank undertaking;				
(iv)	The promoter shall submit the Bank guarantee amounting to Rs. 25 lakhs for submission of approved service plans and estimates. This bank guarantee shall be forfeited in case the conditions are not fulfilled by the promoter within the stipulated time period mentioned in the conditions.				
(v)	The master account (100%) 252560005000 shall be attached. No amount shall be withdrawn from this account till the submission of deficit documents in the authority. It is the responsibility of the concerned bank to freeze the master account till the conditions are not fulfilled by the promoter and the account will be defreeze as intimated by the authority.				
(vi)	In case of failure to submit the approved service plan and estimates within three months' time from the date of issuance of registration certificate and if any allottee who have booked any unit during this period and wishes to withdraw from the project then the amount collected from the allottee will be refunded with interest at the prescribed rate within one month thereafter only.				
(vii)	The promoter shall comply with the requirement of section 4(2)(I)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified				

during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
