(xvii)	The promoter shall declare details of the unit along with specifications, payment plan and time for handing over of possession of unit after obtaining all required approvals from the competent authority.

(ii)	In case of failure to submit the approved service plan and estimates and approved standard design within stipulated time, the registration certificate shall be deemed cancelled and the BG amounting Rs. 25 Lakh submitted for submission of approved service plan and estimates shall be forfeited.
(iii)	The promoter shall comply with the requirement of section 4(2)(I)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
