(xii)	There shall not be any subvention scheme/ assured returned scheme for the registered project without prior approval of the authority.		
(xiii)	The promoter at the time of booking and issue of allotment letter shall be responsible to make available to the allottee, the following information, namely—  (a) Sanction plan, layout plans along with specification, approved by the competent authority, by display at the site or such other place as may be specified by the regulations made by the authority.  (b) The stage wise time schedule of completion of the project including the provisions for civic infrastructure like water, sanitation and electricity. (xiv)	The promoter shall enable the formation an association of allottees or society or co-operative society, as the case may be, of the allottees, or a federation of the same shall be formed, within a period of three months of the majority of allottees having booked their apartment/building/plot and inform the authority about the AOA. (xv)	At the time of issue of allotment letter an application form for membership of the association of allottee shall be got filled up from the allottee.  The promoter shall incorporate a condition in the allotment letter that buyer of unit shall enroll himself as a member of association of allottee to be registered for this project.  Every allottee of the apartment, plot or building as the case may be, shall participate towards the formation of an association or society or corporative society or the allottees, or a federation of the same. (xvi)	The promoter shall issue the allotment letter as per draft annexed in the detailed project information which is duly approved by the authority and		



	authenticated by the promoter. (xvii)	The promoter shall declare details of the unit along with specifications, payment plan and time for handing over of possession of unit after obtaining all required approvals from the competent authority.
(xviii)	As per section 13(1), the promoter shall not accept a sum more than ten per cent of the cost of the apartment, plot, or building as the case may be, as an advance payment or an application fee, from a person without first entering into a written agreement for sale as prescribed with such person and register the said agreement for sale, under any law for the time being in force.

(ii)	The promoter shall submit the Demand Draft amounting to Rs. 25 lakhs for submission of approved service plans & estimates. This Demand Draft shall be forfeited in case the condition is not fulfilled by the promoter within the stipulated time period mentioned in the conditions.
(iii)	The promoter is directed to specifically mention on the prospectus and other relevant literature including notices that the project is being developed by M/s JMK Holdings Pvt. Ltd. which is a fully owned subsidiary of M/s Signature Global India Ltd.
