(G) COMPLIANCES TO BE MADE BY THE PROMOTER (i) The promoter shall submit approved zoning and approved service plans and estimates in the Authority within three months from the date of grant of registration. (ii) The promoter has submitted a guarantee amount of Rs. 25 lacs through cheque no. 005112 dated 27.10.2022 of HDFC Bank on account of submission of approved service plans and estimates within three months. This guarantee amount shall be forfeited in favour of the Authority in case the promoter fails to submit the approved service plans and estimates in the Authority within three months. (iii) The promoter shall submit a bank guarantee of Rs. 25 lacs within a week on account of submission of approved zoning plan in the Authority within stipulated time. In case the promoter fails to submit the approval within stipulated time, the Authority shall be free to forfeit this security amount.
