The registration of this project is approved on 13th February 2023 and shall remain valid for a period of 5 years or till handing over of common areas to local authority/resident welfare association whichever is earlier (Completion Certificate has already been obtained from DTCP vide memo no. The promoter shall incorporate a condition in the allotment letter that buyer of unit shall enroll himself as a member of association of allottee to be registered for this project. Every allottee of the apartment, plot or building as the case may be, shall participate towards the formation of an association or society or corporative society or the allottees, or a federation of the same. [Duty of the allottee under section 19(9)]
(xvi)	The promoter shall issue the allotment letter as per draft annexed in the detailed project information which is duly approved by the authority and authenticated by the promoter.
