 - i) strictly abide by the provisions of the Real Estate (Regulation and Development) Act, 2016 and The Haryana Real Estate (Regulation and Development) Rules, 2017 and The Haryana Real Estate Regulatory Authority, Panchkula (Registration of Projects) Regulations, 2018, and all such other orders that may be issued by the Authority from time to time and will not enter into any agreement with the buyer in breach of the said provisions.

- that the promoter shall submit the quarterly schedule of expenditure vii) from the date of registration upto the date of completion of the project.
- viii) publish this certificate in the printed brochure inviting applications from the prospective buyers for allotment of plots.
- ix) the said project shall be completed by 17.07.2028.

Special Conditions

- Promoter shall submit a copy of service plans/estimates to the İ. Authority immediately after their approval by Town & Country Planning Department.
- Promoter shall submit duly approved building plans in respect of commercial pocket measuring 0.605 acres to the Authority along with deficit fee, if any. Till then, the promoter shall not sell/dispose of any part/unit of the commercial pocket.
