(;;)	The promotor has submitted a DD amounting to 05 laber aid DD

- (ii) The promoter has submitted a DD amounting to 25 lakhs vide DD no 346227 dated 02.04.2024 as a security deposit to submit the requisite access permission and including land diversion within road berm from the competent authority within 4 months of the grant of registration certificate. This DD shall be forfeited in favour of authority in case the conditions are not fulfilled by the promoter within the stipulated time period
- (iii) The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months.
