

	This registration is granted subject to the following conditions, namely:
(i)	The promoter shall enter into an agreement for sale with the allottees a prescribed in the Haryana Real Estate (Regulation and Development) Rules 2017 and amended as per requirements and approved by the authority.
(ii)	The promoter shall offer to execute and register a conveyance deed in favou of the allottee or the association of the allottees, as the case may be, of th unit/apartment, plot or building as the case may be, as per section 17 of th Act;
(iii)	The promoter shall convey/allow usage of common areas as per Rule 2(1)(f) the Haryana Real Estate (Regulation and Development) Rules, 2017.
(iv)	The promoter shall deposit seventy percent of the amounts realized by th promoter in a separate account to be maintained in a schedule bank to cove the cost of construction and the land cost to be used only for that purpose a per sub-clause(D) of clause (l) of sub-section (2) of section 4;

- (v) installations of central services such as electricity, gas, water and sanitation, air-conditioning and incinerating, system for water conservation and renewable energy;
- (vi) the water tanks, sumps, motors, fans, compressors, ducts and all apparatus connected with installations for common use;
- (vii) all community and commercial facilities as provided in the real estate project;
- (viii) all other portion of the project necessary or convenient for its maintenance, safety, etc., and in common use;

(xi) The sale shall not be permitted through real estate agent without availability of prospectus/brochure containing necessary details and a set of drawings and approvals with the real estate agent registered with the HARERA. In case of introduction of new real estate agent or change/deletion of real estate agent as mentioned in the DPI, the promoter shall inform the same to the authority.

(xii) There shall not be any subvention scheme/ assured returned scheme for the registered project without prior approval of the authority.

- (xiii) The promoter at the time of booking and issue of allotment letter shall be responsible to make available to the allottee, the following information, namely-


	(b) The stage wise time schedule of completion of the project including the provisions for civic infrastructure like water, sanitation and electricity.[Obligation of the promoter under section 11(3)]
(xiv)	The promoter shall enable the formation an association of allottees or society or co-operative society, as the case may be, of the allottees, or a federation of the same shall be formed, within a period of three months of the majority of allottees having booked their apartment/building/plot and inform the authority about the AOA. [Obligation of the promoter under section 11(4)(e),]
(xv)	At the time of issue of allotment letter an application form for membership of the association of allottee shall be got filled up from the allottee. The promoter shall incorporate a condition in the allotment letter that buyer of unit shall enroll himself as a member of association of allottee to be registered for this project.
	Every allottee of the apartment, plot or building as the case may be, shall participate towards the formation of an association or society or corporative society or the allottees, or a federation of the same. [Duty of the allottee under section 19(9)]
(xvi)	The promoter shall issue the allotment letter as per draft annexed in the detailed project information which is duly approved by the authority and authenticated by the promoter. In case, the promoter wants to amend certain conditions/clauses, a separate application with justification for such variation/change be submitted for consideration of the Authority and till such change is allowed, the draft allotment letter shall be followed as approved by the authority with the DPI or as per directions issued by the authority.
(xvii)	The promoter shall declare details of the unit along with specifications, payment plan and time for handing over of possession of unit after obtaining all required approvals from the competent authority.
(xviii)	As per section 13(1), the promoter shall not accept a sum more than ten per cent of the cost of the apartment, plot, or building as the case may be, as an advance payment or an application fee, from a person without first entering into a written agreement for sale as prescribed with such person and register the said agreement for sale, under any law for the time being in force.
(xix)	The promoter is obligated to take various approval/renewals whenever due on time, from the competent authorities. Any failure in this regard will invite stringent action as per the provision of the law against the promoter.
(xx)	The promoter shall comply with the requirement of section 11(1) and submit the quarterly up-to-date status of the project for each quarter.
(xxi)	The promoter shall complete the construction of community sites within the completion period declared under section 4(2)(l)(C) of the Act, 2016 and any failure would attract stringent action and penal proceedings.

(G) **COMPLIANCES TO BE MADE BY THE PROMOTER** The promoter shall submit the approved environmental clearance within four (i) months and approved service plans and estimates within two months from the date of grant of registration. (ii) The promoter has submitted the NEFT of Rs 25 lakh vide NEFT no YESBR12024091200008002 dated 12.09.2024 as a security deposit to submit the approval of environmental clearance within four months of the grant of registration certificate. This amount shall be forfeited in favour of authority in case the conditions are not fulfilled by the promoter within the stipulated time period. (iii) The promoter shall not create any third-party rights on the area frozen by DTCP i.e., Pocket-1(4.05625 acres) without obtaining the order of defreeze from DTCP and intimation of the same to the Authority. (iv) The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months. (v) The promoter is directed to clear the title of the project land from any litigations before the offer of possession and if due to the above litigation, any allottee gets the defective title of land and in case of any loss caused to him due to defective title of the land then the allottee would be entitled to get compensation as provided in section 18(2) of the Act. If the above-mentioned conditions are not fulfilled/compliances are not 3. made by the promoter, the Authority may take necessary action against the promoter including revoking the registration granted therein, as per the Act and the rules and regulations made thereunder.
