(iii)	In case of failure to submit the approved environment clearance, fire scheme approval and approved service plans and estimates within stipulated time, the DD amounting Rs. 25 Lakhs each submitted for submission of approved environment clearance, Fire scheme approval and approved service plans and estimates shall be forfeited.
(iv)	The promoter shall comply with the requirement of section 4(2)(l)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
