#### (E) VALIDITY OF REGISTRATION

The registration of this project shall be valid for the **period commencing from 04th March 2025 and ending with 30th April 2030**(completion date as declared by the promoter in REP-II) unless extended by the Authority in accordance with the Act and rules made thereunder subject to compliance of provisions of rule 5(1) of the Haryana Real Estate (Regulation and Development) Rules, 2017.

(ii)	The promoter shall submit the approved environmental clearance within four months from the date of grant of registration, road access permission within



two months from the date of grant of registration and mining permission before start of excavation at site, The promoter has submitted a DD amounting to Rs. 25 lakhs vide DD no (iii) 739463 dated 01.03.2025 of punjab national bank to submit the environmental clearance within four months of the grant of registration certificate. This DD shall be forfeited in favour of authority in case the conditions are not fulfilled by the promoter within the stipulated time period. The promoter shall comply with the requirement of section 4(2)(l)(D) and get (iv) his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months. The promoter is directed to clear the title of the project land from any (v) litigations before the offer of possession and if due to the above litigation, any allottee gets the defective title of land and in case of any loss caused to him due to defective title of the land then the allottee would be entitled to get


