
(E) VALIDITY OF REGISTRATION

The registration of this project/phase shall be valid for the **period commencing from 16th May 2025 and ending with 31st December 2032** (completion date as declared by the promoter in REP-II for this phase) unless extended by the Authority in accordance with the Act and rules made thereunder subject to compliance of provisions of rule 5(1) of the Haryana Real Estate (Regulation and Development) Rules, 2017.

The promoter shall issue the allotment letter as per draft annexed in the (xvi) detailed project information which is duly approved by the authority and authenticated by the promoter. In case, the promoter wants to amend certain conditions/clauses, a separate application with justification for such variation/change be submitted for consideration of the Authority and till such change is allowed, the draft allotment letter shall be followed as approved by the authority with the DPI or as per directions issued by the authority. The promoter shall declare details of the unit along with specifications, (xvii) payment plan and time for handing over of possession of unit after obtaining all required approvals from the competent authority. (ii) The promoter has submitted DD vide no. 517166 dated 09.05.2025 of ICICI bank amounting to Rs. 25 lakhs as a security amount towards the submission of Fire Scheme approval for registration of all the phases. The security amount shall be forfeited in case the respective condition is not fulfilled by the promoter within the stipulated time period mentioned in the conditions. The promoter shall comply with the requirement of section 4(2)(1)(D) and get (iii) his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months. (iv) The promoter is directed to clear the title of the project land from any litigations before the offer of possession and if due to the above litigation, any

allottee gets the defective title of land and in case of any loss caused to him


