(ii)	The promoter has submitted DD bearing no643360 dated 06.02.2025 of ICICI Bank amounting to Rs. 25 lakhs each as a security to submit the approved fire scheme within 3 months from date of grant of registration. These security DD shall be forfeited in case the approved fire scheme is not submitted by the promoter within the stipulated time period mentioned in the conditions.
(iii)	The promoter shall comply with the requirement of section 4(2)(l)(D) and get his accounts audited within six months after the end of every financial year

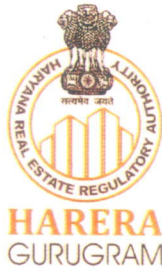

	by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months.
(iv)	The promoter is directed to clear the title of the project land from any litigations before the offer of possession and if due to the above litigation, any allottee gets the defective title of land and in case of any loss caused to him due to defective title of the land then the allottee would be entitled to get compensation as provided in section 18(2) of the Act.
