(iv)	In case of failure to submit Environment Clearence, Fire scheme approval, and approved Service plan and estimates within stipulated time, the BG submitted for submission of Environment Clearence, Fire scheme approval, and approved Service plan and estimates shall be forfeited.
(v)	The promoter shall duly inform the allottees in all the phases of the licensed land regarding the common areas amenities and facilities to be shared as part of the complete licensed land. If any complaint in this regard is received in the Authority and facts found contrary to the submission made than promoter shall be liable for penal action under the Act of 2016.


