There shall not be any subvention scheme/ assured returned scheme for the (xii) registered project without prior approval of the authority. The promoter at the time of booking and issue of allotment letter shall be (xiii) responsible to make available to the allottee, the following information, namely-(a) Sanction plan, layout plans along with specification, approved by the competent authority, by display at the site or such other place as may be specified by the regulations made by the authority.
