

(F) CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

In case of introduction of new real estate agent or change/deletion of real estate agent as mentioned in the DPI, the promoter shall inform the same to the authority. There shall not be any subvention scheme/ assured returned scheme for the (xii) registered project without prior approval of the authority. (xiii) The promoter at the time of booking and issue of allotment letter shall be responsible to make available to the allottee, the following information, (a) Sanction plan, layout plans along with specification, approved by the competent authority, by display at the site or such other place as may be specified by the regulations made by the authority. (b) The stage wise time schedule of completion of the project including the provisions for civic infrastructure like water, sanitation and electricity.

(xvi)	The promoter shall issue the allotment letter as per draft annexed in the detailed project information which is duly approved by the authority and authenticated by the promoter. In case, the promoter wants to amend certain conditions/clauses, a separate application with justification for such variation/change be submitted for consideration of the Authority and till such change is allowed, the draft allotment letter shall be followed as approved by the authority with the DPI or as per directions issued by the authority.
(xvii)	The promoter shall declare details of the unit along with specifications, payment plan and time for handing over of possession of unit after obtaining all required approvals from the competent authority.
(xviii)	As per section 13(1), the promoter shall not accept a sum more than ten per cent of the cost of the apartment, plot, or building as the case may be, as an advance payment or an application fee, from a person without first entering into a written agreement for sale as prescribed with such person and register the said agreement for sale, under any law for the time being in force.

(G) COMPLIANCES TO BE MADE BY THE PROMOTER

- (i) The promoter shall submit the approved Environmental Clearance, approved fire scheme and approved service plans and estimates within four months from the date of grant of registration, approved Electrification plan within 6 months from the date of grant of registration. The mining permission shall be submitted before the start of construction.
- (ii) The promoter has submitted the two DD's amounting to Rs. 25 Lakhs each vide DD no 470502 & 470503 dated 28.10.2025 of Yes Bank as a security deposit to submit the approved fire scheme and approved Environmental Clearance within four months of the grant of registration certificate. These DD's shall be forfeited in favour of authority in case the conditions are not fulfilled by the promoter within the stipulated time period
- (iii) The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months.
- (iv) The promoter is directed to clear the title of the project land from any litigations before the offer of possession and if due to the above litigation, any allottee gets the defective title of land and in case of any loss caused to him due to defective title of the land then the allottee would be entitled to get compensation as provided in section 18(2) of the Act.
- 3. If the above-mentioned conditions are not fulfilled/compliances are not made by the promoter, the Authority may take necessary action against the promoter including revoking the registration granted therein, as per the Act and the rules and regulations made thereunder.
