(ii)	The promoter has submitted the three DD's amounting to Rs 25 lakhs each vide DD no. 511459 dated 05.02.2026, 511460 dated 05.02.2026 and 511483 dated 11.02.2026 as a security deposit to submit the approved Environmental Clearance, Fire Scheme Approval and Approved Service Plans and Estimates within 4 months of the grant of registration certificate respectively. These DDs shall be forfeited in favour of authority in case the conditions are not fulfilled by the promoter within the stipulated time period.
(iii)	The promoter shall submit the mining permission before the start of excavation of the project.
(iv)	The promoter is directed to clear the title of the project land from any litigations before the offer of possession and if due to the above litigation, any allottee gets the defective title of land and in case of any loss caused to him due to defective title of the land then the allottee would be entitled to get compensation as provided in section 18(2) of the Act.
(v)	The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
