

### CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- The promoter shall complete the construction of phase by July 2022 and construction of whole project by July 2024.
- (ii) The promoter shall submit the Service estimates and plans duly approved by competent authority within 90 days;
