

CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- (i) The promoter shall submit the approved service plan estimate, fire scheme approval and environment clearance within 2 months from the date of grant of registration certificate
- (ii) The promoter shall enter into an agreement for sale with the allottees as prescribed by the Government;
