

# CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- (i) The promoter shall submit the approved service estimates and plan, fire scheme approval and environment clearance within 3 months from issuance of this certificate.
- (ii) The promoter shall enter into an agreement for sale with the allottees as prescribed by the Government;
