

CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: -

- (i) The promoter shall submit the renewal copy of licence no. 64 of 2010 and BIP permission, land title search report, Non encumbrance certificate within 3 months from the date of grant of registration certificate.
